In compliance with your Invitation for Bids packet, BIDDER hereby proposes to perform all WORK for the **Washington County Refuse Transfer Station Replacement Slab** project, at 14579 Industrial Park Road, Bristol VA 24202, in strict accordance with the CONTRACT DOCUMENTS at the price or prices stated below.
3. By submission of this BID, each BIDDER certifies, and in the case of a joint BID each party thereto certifies as to his own organization, that this BID has been arrived at independently, without consultation, communication, or agreement as to any matter relating to this BID with any other BIDDER or with any competitor.
4. **ALL BIDS MUST BE SUBMITTED ON THIS FORM.** Bids will only be accepted where pricing is submitted on this Bid Form. All blank spaces for bid prices must be filled in, in ink or typewriter, and the Bid Form must be fully completed and executed when submitted. The OWNER reserves the right to reject any and all bids.
5. Bidder declares that they have examined the specifications of the materials and services and informed themselves fully in regard to all the conditions pertaining to the materials and services; that they have examined the specifications relative thereto and have read all special provisions furnished prior to the submittal of the Bid; that they have satisfied themselves relative to the materials and services provided.
6. The undersigned BIDDER gives as his/her estimated time for completion ~~fourteen (14)~~ **twenty (20) consecutive calendar days for the Base Bid** and agrees to complete the work within that time after receiving a Notice of Award. **Work is to commence within (45) days of Notice to Proceed.**
 - **The undersigned BIDDER gives as his/her estimated time for completion forty-five (45) consecutive calendar days for Additive Alternate A and agrees to complete the work within that time after completion and acceptance of the Base Bid work by the Owner and Engineer.**
7. The BIDDER shall reach Substantial Completion of all work under this contract, as determined by the Architect, within the number of calendar days set forth in the Agreement and Notice to Proceed, as noted above, or otherwise agrees to pay, as liquidated damages, the sum of \$2000.00 for each consecutive calendar day thereafter until Substantial Completion is met. Final completion shall be reached within 30 calendar days of the Substantial Completion date; otherwise, the Bidder agrees to pay the sum of \$500.00 for each consecutive calendar day until Final Completion is met, as determined by the Architect.
8. The bidder has relied upon the following public historical climatological records, for inclusion of expected weather days: NWS Weather Forecast Office for Morristown, Tennessee.

The undersigned hereby proposes and agrees to furnish all necessary labor materials, equipment, tools, and services for the construction required for this project in accordance with the work write-ups, specifications and other Contract Documents prepared by The Lane Group, Inc. / Prosim LLC., for the following amount(s):

<p>Lump Sum Bid Price for Base Bid – Includes Demolition of existing interior slab-on-grade in its entirety and replacement with new 8-inch minimum thick steel-fiber reinforced concrete slab. The extent of this work is between column grids A and J shown on Sheet S100. Note that the interior slab is to be installed and ready for use within 14 20 calendar days from commencement of work. Additional, per Section 7/S300, contractor is responsible for installation of Deadman anchors prior to removal of the slab near the existing hopper retaining wall and responsible for removal and salvage and replacement of existing hopper chute per Section 3/S300. (Revision 1 drawings and Addendum 1 provide an alternate bracing option to the deadman anchor. The Base Bid shall include one of these two options).</p>	\$
<p>Additive Alternate A Lump Sum – Included demolition of existing exterior slab-on-grade in its entirety and replacement with new 6-inch minimum thick steel-fiber reinforced concrete slab.
